#### About the Balkan ORL-HNS

Balkan ORL-HNS is a peer reviewed, open access, online-only journal published by the Balkan Association of Oto-Rhino-Laryngology, Head-and Neck Surgery (https://balkanent.org).

Balkan ORL-HNS is a triannually journal that is published in English in January, May, and September.

All content published in the journal is permanently archived in Portico.

#### Aims, Scope, and Audience

Balkan ORL-HNS aims to be a good edifying journal in the Balkan peninsula and a trustful reference for the world, which publishes studies of the highest scientific, ethical and clinical value, and encourages the submission of high-quality research that advances the understanding of all aspects and sub-specialties of otolaryngology-head and neck surgery. Balkan ORL-HNS also encourages researchers to submit their replication studies and the studies with negative results on common diseases in the region, which are important for the science to develop.

Balkan ORL-HNS covers a wide range of topics related to otolaryngology-head and neck surgery, including otology, rhinology, laryngology, head and neck, otoneurology, audiology, speech and swallowing pathologies, sleep apnea, facial plastics and multidisciplinary research with related sciences.

The journal publishes research articles, case reports, reviews, and letters to the editor.

The target audience of the journal includes healthcare professionals, physicians, and researchers who are interested in or working in the otolaryngology-head and neck surgery, and related disciplines in the Balkan region as well as in the world.

#### **Open Access Policy**

Balkan ORL-HNS is an open access publication.

Balkan ORL-HNS is owned and funded by the Balkan Association of Oto-Rhino-Laryngology, Head-and Neck Surgery. <u>Authors are</u> not required to pay any fees during the evaluation and publication process.

All content published in the journal is licensed under the Creative Commons Attribution-NonCommercial (CC BY-NC) 4.0 International License which allows third parties to use the content for non-commercial purposes as long as they give credit to the original work. This license allows for the content to be shared and adapted for non-commercial purposes, promoting the dissemination and use of the research published in the journal.

When using previously published content, including figures, tables, or any other material in both print and electronic formats, authors must obtain permission from the copyright holder. Legal, financial and criminal liabilities in this regard belong to the author(s).

#### **Copyright Policy**

By signing this form, authors agree that the article, if accepted for publication by the Balkan ORL-HNS will be licensed under a Creative Commons Attribution-Non Commercial 4.0 International License (CC BY-NC 4.0) which permits third parties to share and adapt the content for non-commercial purposes by giving the appropriate credit to the original work. Authors retain the copyright of their published work in Balkan ORL-HNS.

#### Inclusion and Diversity Policy

In order to contribute to reduce biases in scholarly publishing, Balkan ORL-HNS accepts and supports the Joint commitment for action on inclusion and diversity in publishing by applying the Minimum standards on inclusion and diversity at its organizational framework and editorial processes.

#### Sex and Gender Policy

Balkan ORL-HNS contributes sex and gender equity in research and publication by applying the Sex and Gender Equity in Research (SAGER) guidelines at its editorial decision and review processes. Manuscripts, which are discordant to these guidelines, may be rejected.



#### **Environment and Sustainability Policy**

Balkan Association of Otorhinolaryngology, Head and Neck Surgery, and its journal *Balkan ORL-HNS* signs the *UN SDG Publishers Compact.* The Editor in Chief, Cem Uzun, is assigned as the responsible person who will take care of journal activities to be in compliance with the *UN Sustainable Development Goals* (SDG), especially with the SDG3 (Good Health and Well-being), SDG4 (Quality Education), SDG5 (Gender Equality), SDG6 (Clean Water), SDG7 (Affordable and Clean Energy), SDG13 (Climate Action), SDG16 (Peace, Justice and Strong Institutions) and SDG17 (Partnerships for the Goals).

#### Peer Review Process

Manuscripts submitted to Balkan ORL-HNS will go through a double anonymized peer-review process where both authors and reviewers are anonymous to each other. Each submission will be reviewed by at least two external, independent peer reviewers who are experts in their fields in order to ensure an unbiased evaluation process.

Submissions will first go through a technical evaluation process during which the editorial office staff will ensure that the manuscript was prepared and submitted in accordance with the journal's guidelines. Submissions that do not conform to the journal's guidelines will be returned to the submitting authors with technical correction requests.

Submissions that conform to the journal's guidelines will be assigned to the Editor in Chief who will assess each submission's suitability to the journal in terms of scope and quality. Submissions that are not suitable for the journal can be rejected at this stage.

For papers that are suitable for the journal, the Editor in Chief will work with Section Editors who will recruit reviewers for the manuscript. Once assigned, Section Editors can suggest the Editor in Chief to reject a manuscript, continue with the peer review process, or request revisions before further peer-review.

Section editors will submit their recommendations that are based on reports submitted by the reviewers to the Editor in Chief. Revised manuscripts will be reassessed by the Section Editors who will aim to work with the original reviewers to make a new recommendation.

The Editor in Chief is the final authority in the decision-making process for all submissions.

In the event of delays, authors will be informed of the reason for the delay and given the opportunity to withdraw their manuscript.

Once the peer-review process is completed, the authors will receive anonymous peer-review reports along with the editorial decision on their manuscript. Peer-review reports will not be posted publicly in any medium. The submitted material is considered confidential and must not be used in any way until after its publication. If it is suspected that a reviewer has appropriated an author's ideas or data, the Editorial Board will handle the matter in accordance with the relevant COPE's guideline.

Authors can recommend peer-reviewers during submission. The handling editor is the sole authority to decide whether or not recommended peer-reviewers will be invited to evaluate the manuscript.

Peer reviewers are required to adhere to the principles of COPE's Ethical Guidelines for Peer-reviewers. These guidelines provide a framework for reviewers to follow in order to ensure the integrity and fairness of the peer review process. The Editorial Board follows COPE's relevant flowchart to minimize peer review manipulation. If there is suspicion of peer review manipulation after publication, the Editorial Board will follow the appropriate flowchart of COPE.

Potential peer reviewers should inform the Editor in Chief of any possible conflicts of interest before accepting an invitation to review a manuscript. Informing the editor of any potential conflicts of interest allows them to make an informed decision about whether or not to invite the potential reviewer to participate in the review process. It also helps to ensure the integrity and transparency of the review process.

Communications between Editors and peer reviewers contain confidential information that should not be shared with third parties.

#### Handling Papers from Editorial Board Members

To ensure an equitable peer-review process, the Balkan ORL-HNS will recruit external editors for manuscripts submitted by the Journa's editorial board members. External editors will be selected based on academic qualifications and peer-review experience. We uphold the confidentiality of external editors and reviewers to preserve impartiality. Reviewers and external editors are asked to disclose any potential conflicts of interest, promoting transparency and a reliable evaluation process.



If an article's peer review is an exception to the journal's usual policy, the type of the review it received will be displayed on the article to ensure the transparency and accountability of the review process.
